
QUIZ

In June 2023, the Supreme Court concluded the landmark case of Mead v Paul. The Supreme Court dismissed the appeal of the Court of Appeal's decision deciding that the Family Court did have jurisdiction to determine the relationship property rights of three persons in a contemporaneous polyamorous relationship under the Property (Relationships) Act 1976 (PRA).

L Paul and B Paul married in 1993. In 2002 they formed a polyamorous relationship with F Mead. Soon after the polyamorous relationship began, F Mead purchased a farm (the property in dispute). The farm deposit was paid by her, and the farm was registered solely in her name. The three of them lived in the property together for 15 years until 2017 when L Paul separated from B Paul and F Mead. In 2018 F Mead and B Paul also separated. The property remained in F Mead's name, and she remained a resident.


During the 15 years together living at the property each party contributed in different ways to household activities and general upkeep of the property.

In 2019, L Paul brought an application for relationship property order in the Family Court and claimed her one-third share in the property – the family home. B Paul did the same. They both argued that there were three qualifying relationships under the PRA, namely two de facto couples and one married couple. F Mead argued that the Family Court did not have jurisdiction of the claim as the parties did not have qualifying relationships under the PRA.

The question of whether the Family Court has jurisdiction to determine the property rights of three persons in a contemporaneous polyamorous relationship under the PRA was first decided in the High Court. Hinton J said no – her Honour's view was that the PRA did not apply to a polyamorous relationship, and it would be unfeasible to apply the PRA to complex relationships such as a polyamorous relationship.

The decision was subsequently appealed and heard by the Court of Appeal. The Court of Appeal allowed the appeal. Whilst the Court of Appeal agreed with the High Court that polyamorous relationships were not a qualifying relationship under the PRA the Court of Appeal deemed that there could be multiple qualifying relationships between couples within a multi-partner relationship. The Court of Appeal found that in this case there had been three distinct qualifying relationships between the L Paul, B Paul and F Mead. 5. Can a triangular relationship (with mutual cohabitation and sexual relations) be subdivided into three qualifying relationships?


[77] The question now becomes whether triangularity makes a difference to that analysis. In practical terms (in the context of these facts) it adds one additional material factor to the relationship structure described at [73] above: a sexual relationship between all three.



The Supreme Court dismissed the appeal and the majority agreed with the Court of Appeal.

However, the minority dissented that it was artificial to recharacterise a relationship involving three people into distinct couples given how they viewed their own relationship and lived all together as one unit.
